III. Podaci o zdravstvenom stanju / Health attestation

Potpisani službeni veterinar potvrđuje da/ The undersigned official veterinarian hereby certifies that:

- su životinje prije utovara pregledane i da tom prilikom nisu pokazivale kliničke znake koji upućuju na sumnju na prisustvo zaraznih bolesti koje se mogu prenijeti tom vrstom životinja/ each animal in the consignment has been examined, at loading showing no clinical signs of suspected contagious diseases which could be transmitted by the species;
- u kraju iz kojeg životinje potiču i u krugu od 30 km u njegovoj okolini u protekla 3 mjeseca nije bilo slučajeva bolesti sa A liste OIE koda/ in the place of origin of animals and in the radius of 30 km from the place, within the past 3 months there have been no incidences of diseases of the A-List of the OIE Code;
- su životinje boravile u mjestu porijekla najmanje 90 dana prije otpreme/ animals have remained in the place of origin for at least 90 days prior to shipment

- životinje potiču iz objekata koji su pod veterinarsko – sanitarnim nadzorom i da su slobodne od zaraznih bolesti koje se obavezno prijavljuju i lako prenose tom vrstom životinja/ animals originate in holdings, which are under veterinary-sanitary inspection and control and free of contagious diseases which should be reported and which could be transmitted by this animal species;
- su životinje pregledane na prisustvo parazita i salmonelozu najmanje 30 dana prije utovara sa negativnim rezultatom/ animals have 30 days at the most prior to loading been examined for parasites and salmonellosis with negative result;
- su životinje boravile u objektima ili oborima u kojima nije bilo pojave slučajeva tuberkuloze u periodu od najmanje 2 godine prije isporuke/ animals have been kept in buildings and enclosures in which no cases of tuberculosis have occurred during the last two years prior to shipment;
- na putu prema mjestu utovara i odašiljanja životinje nisu prošle kroz područje u kojem su raširene zarazne bolesti koje se obavezno prijavljuju/ on the way from the place of loading and dispatch, the animals have not been conveyed through areas with the spread of contagious diseases which should be reported;
- hrana i prostirka za životinje potiču iz krajeva u kojima u zadnja tri mjeseca nije bilo ni jednog slučaja bolesti sa bivše A liste OIE koda niti iz antraksnog distrikta/fodder and litter accompanying the animals originate in areas, where no cases of former A-List diseases of the O.I.E. Code have been detected within the past 3 months, and that they do not originate in an anthrax district
- su prevozna sredstva za životinje konstruisana tako da je onemogućeno svako istjecanje ili ispadanje otpadaka od hrane i prostirke, te da su životinje utovarene tako je sprječeno njihovo mučenje tokom transporta/vehicles for transport of animals have been so constructed as to prevent any flowing or falling out of waste fodder and litter, and that animals have been loaded so as to prevent suffering during transport;
- su prevozna sredstva prije utovara očišćena i dezinficirana/ vehicles have prior to loading been cleaned and disinfected
